

## **CoraZazenvillas (“we” or “us”) uses cookies.**

By using the CoraZazenvillas.com website, every visitor agrees to the possible use of necessary cookies and non-necessary cookies for which no permission is required due to a specific configuration (including anonymization of IP addresses), in accordance with applicable regulations. With other (optional) cookies, your permission would be requested when opening the website.

If you prefer not to use the cookies, you as a visitor are free to disable the cookies and/or withdraw your consent (see below).

CoraZazen is responsible for this cookie policy, which applies to the (mentioned) website of CoraZazen and – in which it is clearly and simply explained which cookies are used, why and how you can control those cookies.

### **I. What are cookies and why do we use them?**

A cookie is a small text file that is placed on, for example, your computer, tablet or smartphone during your visit to our website. Information is stored in this text file. This information can be recognized again by the website on a later visit.

If necessary/possibly personal data (including pseudo-anonymous data) about you can be processed via the cookies, which would allow you to be identified. If personal data is involved, the principles from our privacy policy also apply to the relevant processing of personal data via the cookies.

In particular, CoraZazen generates (web) statistics via the cookies, in order to improve its services/website. CoraZazen uses the data it collects via the cookies, if necessary also in the context of legal (reporting) obligations.

### **II. What types of cookies are used?**

We use analytical cookies. These cookies collect information about the visitor's behavior on the website in order to compile (web) statistics in order to improve our services/website.

We use third-party cookies (= cookies that a third party places and/or manages-), and the following first-party cookies (= cookies that we place, manage and from which we receive the determined data-):

- PHPSESSIONID: Default method to implement sessions in php (default TTL (= expiry period) 3 days, but customizable)

- ccKey: Identifier to link the user to his cookie choices (functional-analytics-marketing accepted or rejected).
- ccFunctional: cookie to keep track of whether functional cookies are accepted.
- ccAnalytics: cookie to keep track of whether analytical cookies are accepted.

### **III. Management of the cookies**

To enable cookies, the following actions must be performed:

#### **Google Chrome**

- Click on the three dots next to the browser bar at the top of your browser window and choose 'Options'.
- Find the 'Privacy and security' section and click on 'content settings'.
- Click on the 'cookies' option.
- Now select 'Allow sites to save and read cookie data'.

#### **Microsoft Internet Explorer**

- Click on 'Internet Options' in the 'Tools' menu.
- On the 'Privacy' tab, move the settings slider to 'low' or 'accept all cookies' (setting above 'medium' disables cookies).
- Click on 'OK'.

#### **Mozilla Firefox**

- Click on 'Firefox' in the top left corner of your browser and then click on 'Options'.
- On the 'Privacy' tab, make sure the 'Tell websites I don't want to be tracked' is not checked.
- Click on 'OK'.

#### **Safari**

- Choose 'Preferences' from the task menu. (The task menu is located at the top right of the Safari window and looks like a gear or click "Safari" in the expanded task menu.)
- Click on the Privacy tab. Locate the section called "Cookies and other website data"
- Indicate that you do not accept cookies.

### **IV. What are your rights as a visitor?**

As a visitor to our website, your personal data may be processed by the use of certain cookies.

In the aforementioned case, you enjoy data portability in accordance with the General Data Protection Regulation (including access, rectification, erasure, restriction, objection, withdrawal of your consent), which we have described in more detail in our privacy statement,
